Chairman Armistead,

This is a request to deny Republican ballot access to Nathaniel Ledbetter for House Seat District 24. It is our sincere belief that Mr. Ledbetter seeks to run as a Republican because he knows that there is little chance for a non-incumbent Democrat to be elected. Furthermore, we believe that the evidence we present will support the facts that Mr. Ledbetter is still aligned with and loyal to the democratic party.

Lowell Barron's loss shook and David Rains loss shattered the foundation of the democratic party in Dekalb County. Mr. Ledbetter ran for this office as a Democrat in 2010. He lost, getting 46% of the vote. Now, he hopes to bring these democrat voters into the Republican primary needing only 4 or 5% of the republican vote to allow him to move on to be unopposed in the general election. We do not believe that becoming a Republican one day and the Republican candidate the next day is good for our party. We believe a candidate should work in the trenches for the party and for party candidates to prove themselves. We can find no evidence that Mr Ledbetter has ever offered any support to the Republican Party or any Republican candidate. Perhaps, in 2 or 4 years, Mr. Ledbetter will have demonstrated support of the party and that he deserves access to the Republican ballot.

The most troubling issue is that Mr. Ledbetter's **known** democratic supporters are still financing him in 2014. Please review the attached campaign reports with the cross references from the Secretary of State's website and you will find the evidence we have detailed below.

Mr. Ledbetter's campaign finance reports gives insight to the people that support him. Of the 5 filed reports ending in January 2014, he has taken 19 cash contributions not including himself, his wife, or polling.

Fifteen of the 19 contributions taken come from known democratic supporters and they are highlighted by number on his 2014 republican and 2010 democrat reports.

These 15 contributors represent 79% of his 2014 financial support and are known long time democratic contributors.

Mr. Ledbetter has taken \$4750.00 in cash contributions The 15 known democratic contributors totals to \$3806.00, equaling 80% of his total contributions in 2014.

Futhermore, Mr. Ledbetter shows no pride in being a republican; he does not identify himself as a republican on any of his 2014 literature or signs.

Also included are photographs of Mr. Ledbetter's mobile sign mounted to a trailer tagged to and owned by (15.) Mr. Reggie Bynum, another longtime democratic supporter. And, a photograph of his 2014 campagin sign on Lowell Barron's property on Al. Hwy. 35.

Copies of his attending the democratic caucus, from his face book 1/12/2012.

The evidence presented speaks for itself. Mr. Ledbetter has support from the democratic party. For these reasons, we believe that Nathaniel Ledbetter is not worthy or deserving of consideration for Republicans in House District 24. We urge that he be refused access to the ballot out of hand.

Please forward this to the Steering Committee for review, and we stand ready to address these concerns in a formal hearing before the Committee.

SUBJECT: Nathaniel Ledbetter Campaign

I met with Nathaniel Ledbetter, at his request, for lunch at Katy's Katfish Restaurant on March 1, 2013. Mr. Ledbetter had been the democrat nominee for Alabama State House of Representatives, District 24, in 2010, and lost to the republican incumbent. He wanted to meet with me to get my thoughts regarding his switching to the Republican Party and running for the same house seat in the upcoming election.

I responded to his question saying his switching parties were a personal decision for him to make and did not require my approval or disapproval. As to the second part of his question, I told him that with the intensity of his last campaign still fresh in everyone's mind, many republicans might be skeptical of his motives. I further stated that it might be better for him if he worked for a republican candidate or two before conducting his own campaign under the republican banner, because he would have more credibility with many in the party.

His response was that he didn't think that would be a problem because he only needed a little over 3% of them because he got almost 47% as a democrat in the last race.

I was a bit surprised by his response and told him not to be so sure because a lot of "yellow dogs" would be upset with this decision and would never forgive him for these actions. He was steadfast in his opinion that most of his previous supporters would stick with him.

I then ask him if all the democrats were sticking with him, why would he want to run as a republican rather than a democrat? He said the Republican Party is viewed as more conservative and he was going to make sure to inform the voters that he was conservative.

Finally, I asked him why he felt he was a conservative. He said because he was against gays and abortion. But when I asked about specific issues, such as; Education/AEA, Second Amendment/Gun Rights, expanding Medicaid, business initiatives, etc., he had no answers rather than to say "I will take a conservative position."


Mr. Ledbetter asked if I would support him in his campaign. I told him I was not going to endorse any republican candidate over another until after the primary election.

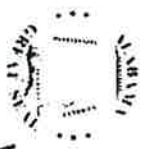

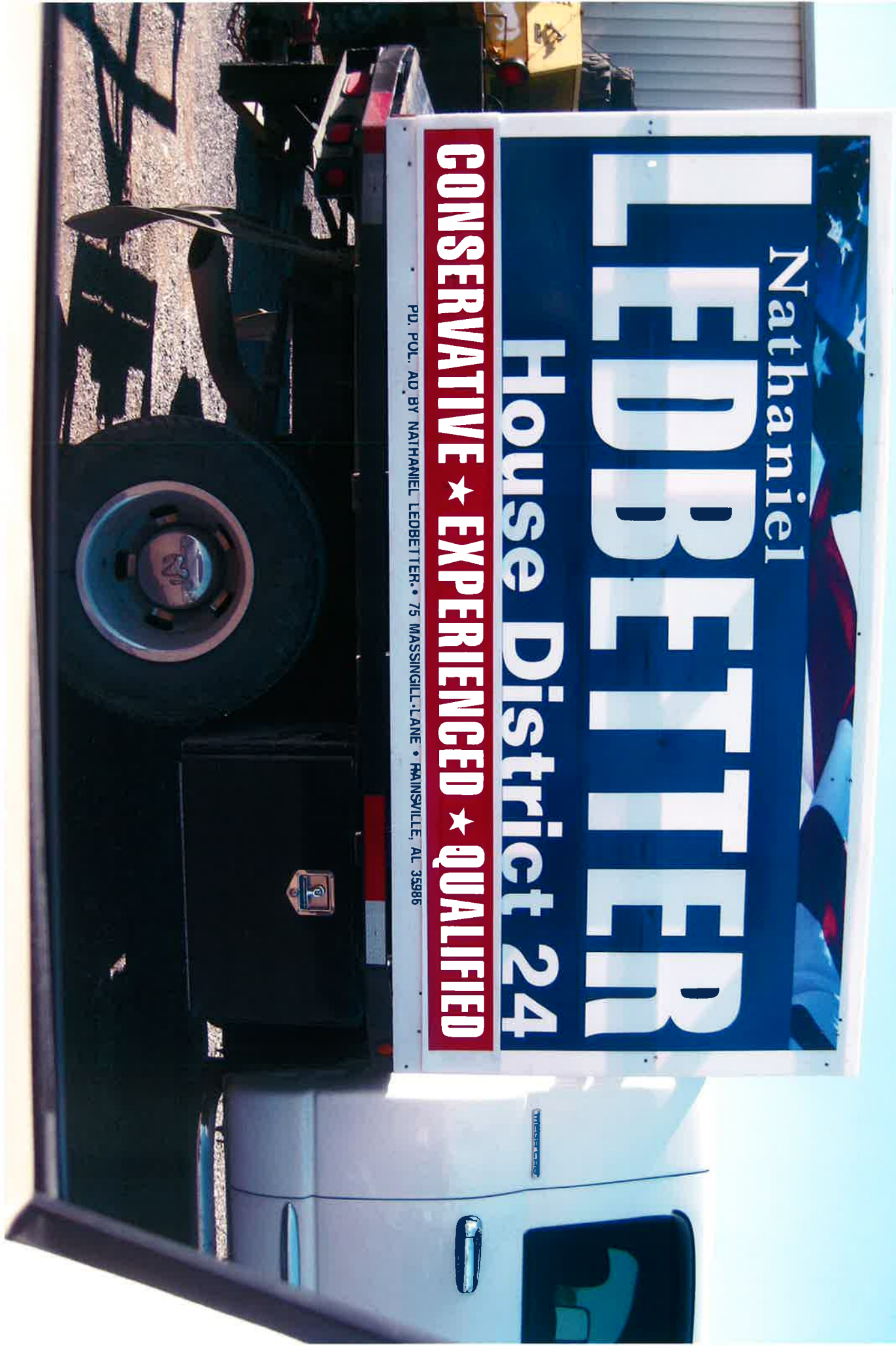

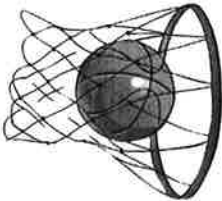
